

NOTIFICATION OF LENNOX EXTENDED LIMITED WARRANTY

(ONLINE REGISTRATION REQUIRED at www.lennoxwarranty.com)

Lennox Industries Inc. (Lennox) provides certain components in its Merit® series gas furnaces, with a basic five-year limited parts warranty. An extended limited parts warranty is available for certain components in ML195DF and ML195UH units in the Merit series product line. This extended limited parts warranty is intended to supplement the basic five-year limited parts warranty with an additional five (5) years of limited warranty coverage; therefore, providing a total of ten (10) years of limited warranty coverage for applicable components. In addition, the extended limited warranty supplements the 20-year limited warranty coverage on the heat exchanger to provide a limited lifetime warranty on the heat exchanger only. **The extended limited warranty requires online registration.** Other requirements apply, in addition to the requirements and exclusions set forth in the basic warranty. This extended limited warranty covers eligible units and components only and does not include labor.

COVERED EQUIPMENT

The Lennox extended limited warranty is being offered for applicable components in ML195DF and ML195UH gas furnaces in Lennox' Merit series product line.

EQUIPMENT ELIGIBILITY REQUIREMENTS

Covered equipment must meet the following requirements:

- 1 - The equipment must be Lennox-branded Merit series ML195DF and ML195UH gas furnaces.
- 2 - The equipment must be installed in a "Residential Application." (Residential Application is an owner-occupied, single-family dwelling which includes homes, duplexes and condominiums.) Commercial Applications are not eligible for this extended limited warranty.
- 3 - The equipment must be installed per the manufacturer's instructions by a licensed professional installer, or equivalent.
- 4 - Installation must take place on or after January 1, 2011.
- 5 - The extended limited warranty is being granted to the original purchaser, who must occupy the residence at the time of the warranty claim. The extended limited warranty is not transferable.
- 6 - The equipment must be properly registered at www.lennoxwarranty.com within 60 days after the date of installation or closing date, except where prohibited by law. Proof of purchase or closing date may be required.

TERMS AND CONDITIONS

Unless modified herein, all terms and conditions set forth in the basic warranty remain the same. These include, but are not limited to, component availability, excluded components, repairs, care of equipment, coverage, exclusions, warranty procedures and dispute resolution.

NOTE - Registering your product does not guarantee the manufacturer's warranty or extended warranty or the application thereof. If the registered product does not meet all qualifying factors and/or requirements for standard or extended warranty, or falls within one of the warranty limitations, the warranty will not apply to the equipment and/or your product regardless of the fact that the product is registered.

NOTE - Lennox reserves the right to cancel this extended limited warranty program at any time, without notice. Warranties properly registered at the time of program cancellation will continue to be honored.
