

NOTIFICATION OF LENNOX EXTENDED LIMITED WARRANTY

(ONLINE REGISTRATION REQUIRED at www.lennoxwarranty.com)*

EXCEPT IN CALIFORNIA, QUEBEC OR WHERE REGISTRATION REQUIREMENTS ARE PROHIBITED BY LAW

Lennox Industries Inc. (Lennox) provides certain components in its Elite® and/or Merit® series air conditioners, air handlers, boilers, indoor/evaporator coils, gas furnaces, oil furnaces, heat pumps, and residential packaged units with a basic five-year limited parts warranty. An extended limited parts warranty is available for certain components in select products in the Elite and Merit series product lines. This extended limited warranty is intended to supplement the basic five-year limited parts warranty with an additional five (5) years of limited warranty coverage; therefore, providing a total of ten (10) years of limited warranty coverage for applicable components. The extended limited warranty requires online registration. Other requirements apply, in addition to the requirements and exclusions set forth in the basic warranty. This extended limited warranty covers eligible units and components only and does not include labor.

COVERED EQUIPMENT

The Lennox extended limited warranty is being offered for applicable components in select air conditioners, air handlers, boilers, indoor/evaporator coils, gas furnaces, oil furnaces, heat pumps, and residential packaged units in Elite and/or Merit series product lines.

EQUIPMENT ELIGIBILITY REQUIREMENTS

Covered equipment must meet the following requirements:

- 1 - The equipment must be Lennox-branded Elite and/or Merit series air conditioners, air handlers, boilers, indoor/evaporator coils, gas furnaces, oil furnaces, heat pumps, and residential packaged units
- 2 - The equipment must be installed in a "Residential Application." (Residential Application is an owner-occupied, single-family dwelling which includes homes, duplexes and condominiums.) Commercial Applications are not eligible for this extended limited warranty.
- 3 - The equipment must be installed per the manufacturer's instructions by a licensed professional installer, or equivalent.
- 4 - Air handlers, indoor/evaporator coils, air conditioners, heat pumps and residential packaged units must use R-410A refrigerant. Air handlers, indoor/evaporator coils, air conditioners and heat pumps must be part of an AHRI-matched system.
- 5 - The system must comply with regional standards.
- 6 - Installation must take place on or after March 1, 2009 for all products except coils, which are eligible as of January 1, 2012, boilers which are eligible as of September 1, 2015 and oil furnaces as of January 1, 2021.
- 7 - The extended limited warranty is being granted to the original purchaser, who must occupy the residence at the time of the warranty claim. The extended limited warranty is not transferable.
- 8 - *To obtain this extended limited warranty for equipment purchased outside of California or Quebec (or where registration is prohibited by law), the equipment must be properly registered at www.lennoxwarranty.com within 60 days after the date of installation or closing date. Proof of purchase or closing date may be required. FOR EQUIPMENT PURCHASED IN CALIFORNIA OR QUEBEC (OR WHERE REGISTRATION IS PROHIBITED BY LAW), REGISTRATION IS NOT REQUIRED TO OBTAIN THIS EXTENDED LIMITED WARRANTY AND THE FAILURE TO REGISTER YOUR EQUIPMENT WILL NOT DIMINISH YOUR EXTENDED LIMITED WARRANTY OR YOUR RIGHTS THEREUNDER.

TERMS AND CONDITIONS

Unless modified herein, all terms and conditions set forth in the basic warranty remain the same. These include, but are not limited to, component availability, excluded components, repairs, care of equipment, coverage, exclusions, warranty procedures and dispute resolution.

NOTE - Registering your product does not guarantee the manufacturer's warranty or extended warranty or the application thereof. If the registered product does not meet all qualifying factors and/or requirements for standard or extended warranty, or falls within one of the warranty limitations, the warranty will not apply to the equipment and/or your product regardless of the fact that the product is registered.

NOTE - Lennox reserves the right to cancel this extended limited warranty program at any time, without notice. Warranties properly registered at the time of program cancellation will continue to be honored.

If you need assistance gathering this information, please contact the installing contractor. *If you purchased equipment in California, Quebec or where registration requirements are prohibited by law, registration is not required and the failure to register your equipment will not diminish your warranty or rights thereunder.
